In his opening remarks, Dr. N.T. Rikam, Registrar (Ex-Officio Secretary) extended warm welcome to all the esteemed members who were present both in physical and virtual mode. He informed that this Executive Council Meeting is a very special ceremonial meeting which is conducted prior to the Annual Convocation for approval of the EC regarding awarding of Degrees (UG/PG/M. Phil) and Gold Medals to the students during the convocation.

With the permission of Chairman (Ex-Officio), Dr. David Pertin, Joint Registrar (Aca/Conf), i/c presented the Agenda of the 54th Meeting of Executive Council in chronological order before the members for their perusal and consideration.

	The Council noted and approved the placement of Department of Psychology under the Faculty of Social Sciences as the said proposal has already been approved by the 45 th Academic Council under Item No. AC:45:09 held on 29.11.2023.	
EC:54:05	To approve the recommendations of various Selection Committees for filling up of teaching positions in the categories of Professor, Associate Professor and Assistant Professor of various Departments through direct recruitment interview held w.e.f. 8 th November, 2023. The sealed minutes/reports of the same were placed in the Executive Council Meeting.	



The Council perused and approved the recommendations of various Selection Committees. The Council unanimously decided that the probation period be extended from one year to two years for these faculty members. It was further resolved that the university shall exercise the police verification/verification of testimonials and all consequential benefits viz., addition/counting of past services, fixation of pay, seniority and other benefits would be provided to them from the date of Joining only after completion of probation period of two (1+1) years, and the ordinances of the university also be amended/modified to this effect. This shall come into force with immediate effect.

Ratification Items:

- (1) Dr. Arindam Garg, Associate Professor, Dept. of Management of this university has been granted three (3) years Lien w.e.f. 04.07.2023 to 03.07.2006 to enable him to join as Registrar at Cotton University, Guwahati, Assam.

The Council perused and approved the ratification. However, Dr. Arindam Garg, Associate Professor, Dept. of Management of the university be granted <u>two years Lien</u> w.e.f. 04.07.2023 <u>instead of three (3) years</u> as per standard practice of the university. A revised order be issued accordingly to this extent.

To consider the approval of the Gold Medal and degrees (UG & PG including M. Phil) to given away to the students/scholars during XXI Convocation scheduled on 30th November, 2023.

Award of Gold Medalists:

EC:54:07

The Council noted that this year a total of one (1) Chancellor's Gold Medal for PG. In PG a total of 38 gold medalists (14 male and 24 female) will be awarded in person during XXI Convocation to be held on 30.11.2023. While in UG category, a total of 30 (09 male and 21 female). Further, total numbers of 6186 in UG and 969 in PG shall be conferred. The matter was placed and accordingly approved by the 45th Meeting of the Academic Council held on 29.11.2023 vide Item No. AC:45:29. The same be recommended to the Executive Council for further approval. The detail list of the Gold Medalists was placed as Annexure-06.

Award of Ph. D. Degrees:

Award of Ph.D. degrees to 120 Research Scholars in the respective discipline during the period 1st December, 2022 to 29th November, 2023. The Executive Council noted that the university has declared following Research Scholars to have qualified for the award of Ph. D Degree in their respective disciplines. This year a total of 120 Ph. D. (43 male and 77 female)



degrees will be conferred. The matter was placed and approved by the 45th Meeting of the Academic Council held on 29.11.2023 vide Item No. AC:45:30. The same be recommended to the Executive Council for further approval. The detail of the Ph.D. scholars was placed as Annexure-07.

Award of M. Phil Degrees:

The Council noted that a total of 28 M. Phil (14 male and 14 female) degrees will be conferred. The matter was placed in the 45th Meeting of Academic Council held on 29.11.2023 and approved the same and recommended to Executive Council.

The degrees will be conferred in person on the candidates during the XXI Convocation of the University scheduled on 30th November' 2023. The matter was placed and approved by the 45th Meeting of the Academic Council held on 29.11.2023 vide Item No. AC:45:30. The same be recommended to Executive Council for further approval. The detail of the M. Phil degree holders was placed as Annexure-08.

The Executive Council perused and approved the same. The Council greeted the university for awarding a huge number of Ph.D. degrees in the XXI Convocation. The Council further lauded that the females are achieving more gold medals/Ph.D. degrees in comparison to male. It is a good gesture for the university in days to come.

Any other Items:

(a) To approve the guidelines for the Recruitment Process for various Non-Teaching positions (Group-A, B and C) under Direct Recruitment.

The Council noted that the university has constituted a Committee to prepare the guidelines for the Recruitment Process for various non-teaching positions under direct recruitment against advertisement No. Estt.-188/2011/Pt., dated 26th July, 2023; and No. Estt.-188/2021/Pt.-II, dated 30th October, 2023. The Committee prepared the guidelines in accordance with the DoPT and analogy drawn from a few Central Universities (Tezpur University, Assam, NEHU, Meghalaya, etc.) situated in the North-Eastern Region.

The Council thoroughly perused the guidelines and approved the same for further action on its implementation with immediate effect.

As there was no other item to discuss, the meeting ended with a Vote of Thanks from the Registrar.
