In pursuance of Order No. PP/DC/ILP-103/2025/5196 dated 30th April 2025, issued by the Deputy Commissioner, Papum Pare District, Yupia, Arunachal Pradesh, and in order to prevent any untoward incidents, and facilitate maintenance of law and order; and other ancillary activities within the university campus, the following advisories/directions are hereby issued for immediate compliance:

- Engagement of Labourers: No individual shall be engaged as a labourer or daily wager within 1. the university premises unless they possess a valid Inner Line Permit (ILP) issued by the competent authority of the Government of Arunachal Pradesh.
- Maintenance of Records: The University shall maintain a comprehensive register of all 2. engaged workers, clearly recording details of their ILP, permanent address, period and nature of engagement, and valid identification documents. These records shall be produced without fail upon request by any officer duly authorized by the District Administration or the Police.
- Post-Engagement Procedures: Upon completion of work or termination of engagement, the 3. university shall ensure that all such individuals are deported to their place of origin. A written intimation confirming the same shall be submitted without delay to the nearest Police Station and the concerned Administrative Officer.
- Verification of Documents: The Senior Security Officer shall immediately initiate and 4. continue routine checks for verification of ILP and other valid documents of all engaged individuals.

These directives shall be implemented with immediate effect and will remain in force until further order.

// ORDER //

Whereas, in pursuance to the decisions taken during the meeting held under the chairmanship of the Hon'ble Minister (Home), Government of Arunachal Pradesh, and in view of prevailing security concerns and the statutory requirements under the Bengal Eastern Frontier Regulation, 1873, it has become imperative to ensure strict enforcement of Inner Line Permit (ILP) regulations in relation to the engagement of labourers and daily wage workers by Institutions and technical departments within Papum Pare District;

And whereas, it has been brought to the notice of the undersigned that institutions such as Rajiv Gandhi University (RGU), Doimukh; Government College, Doimukh; Jarbom Gamlin Government Law College, Jote; National Institute of Technology (NIT), Jote; Film and Television Institute (FTI), Jote; and various Engineering and Technical Departments are engaging labourers for construction, maintenance, and other ancillary activities within their respective campuses;

Now, therefore, in exercise of the powers conferred under the Bengal Eastern Frontier Regulation, 1873 and in the interest of public safety, regulatory compliance, and to prevent any untoward incident, the undersigned hereby issues the following directions for strict and immediate compliance:

- No individual shall be engaged as a labourer or daily wager within the premises of any institution or department unless in possession of a valid Inner Line Permit (ILP) issued by the competent authority.
- ii. The Institution/Department shall maintain a comprehensive register of all such engaged workers, recording details of their ILP, permanent address, period and nature of engagement, and valid identification documents. These records shall be produced without fail upon request by any officer duly authorized by the District Administration or the Police.
- iii. Upon completion of work or conclusion of the engagement, the concerned institution shall ensure that all such individuals are deported to their place of origin, and a written intimation to this effect shall be submitted to the nearest Police Station and the concerned Administrative Officer of the area without delay.
- iv. All institutions are further directed to facilitate inspection, verification, and enforcement actions undertaken by Administrative Officers and Police personnel in connection with ILP compliance.

These measures shall be implemented as a preventive mechanism to avert any breach of peace, security lapse or violation of existing regulatory frameworks. Non-compliance with the aforementioned directions shall attract strict action under the (BEFR) Act, 1873 and other applicable legal provisions.

This order shall come into force with immediate effect and shall remain in operation until further

orders.
