In Arunachal Pradesh, a new Student Activity Center, under construction by the Urban Department for the past six years, has yet to be handed over to RGU, further delaying the resolution of infrastructure gaps.
(d)	If so, the details thereof?	To address these challenges effectively, there is a critical need for dedicated infrastructure development at RGU, including: 1. A multi-purpose stadium for athletics and other outdoor sports. 2. Indoor sports complexes for volleyball, basketball, badminton, and table tennis. 3. A synthetic athletic track and an Olympic-standard swimming pool. 4. Facilities for hockey and cricket, including stadiums. 5. Modernizing existing infrastructure for inclusive sports participation. Therefore, immediate attention to fund allocation and project execution is essential to meet the growing sports demands of students in Central Universities like RGU. A coordinated effort involving UGC, Ministry of Education, State Governments, and private entities is vital to bridge these gaps.


