The IQAC is represented by members from Public in the form of External Experts, Student, & Alumni along with university Officers, and Faculty Members. The IQAC takes feedback from students/ teachers/ parents/ employees/ alumni on above points, conducts Administrative/ Academic/ Laboratory/ Library / Curriculum Audit, analysis the whole situation, and draft policy proposals to be forwarded to Statutory Bodies for Approval & Implementation.


