## SoP to be followed by the Departments for Admission through CUET-PG 2025

- 1. CUET-PG 2025 application details will be given to the Departments (hod.\_ Computer Centre (10.01.2025 onwards). Access will be provided through HoD's RGU email
- 2. Screening and assign of weightage as per guidelines by the Department (10-11.06.2025)
- 3. To prepare full length merit list: category wise and notify (11.06.2025). Send email message to
- 4. Contact the candidates as per the merit list sequence-wise starting with open category seats for counselling over phone / Google Meet, etc. (12.06.2025)

5. Candidates fulfilling eligibility (marksheet and pass in qualifying exam) as per the merit list, will be advised to pay prescribed fee through Samarth.

6. Candidates in the merit list awaiting their final semester results will be advised to pay the Seat Retention fee (₹1000/- non-refundable) through the link available in rgu.ac.in.

7. If a candidate from the merit list during counselling declines to take admission in RGU (Payment of admission fee OR Seat retention fee), the next candidate in the merit list will be offered the seat. The Committee will prepare and keep the record. This process will continue till the number of available seats (20% of intake including EWS) are filled.

8. There will be no waiting list.

- 9. The Department will send the list of candidates in excel file along with:
  - a. Form number
  - b. Programme Name
  - c. Candidate's Name
  - d. Fathers name
  - e. email
  - f. Mobile
  - g. Male / Female
  - h. Category
  - i. Fee payment
    - 1. Allowed for Admission fee and amount
    - 2. Allowed for Seat Retention Fee
- 10. If there are no sufficient number of candidates, the vacant seats will be transferred to RGUCET based seats.

11. Seat Retention fee may be paid by 20.06.2025

12. The last date of admission (payment of fee) will coincide with the RGUCET-2025 admission schedule.
