CUET-2025 ADMISSION NOTICE-III (FINAL)

The following candidates who have paid the Seat Retention Fee are hereby directed to pay the requisite Admission Fee of **₹7,150 (Rupees Seven Thousand One Hundred Fifty)** by **31 July 2025** through their Samarth Account. They are further required to send all their documents (along with the payment receipt and the final year/semester marksheet) in **one pdf folder** to the HoD's mail id: head.history@rgu.ac.in Candidates who have already paid the Admission Fee are also hereby directed to email all their documents (along with the payment receipt and the final year/semester marksheet) in **one pdf folder** to the HoD.

The documents are to be scanned in the following order:

- a) Education Qualification: mark sheets and certificates of class X, XII and Graduation.
- b) College Leaving Certificate.
- c) Caste/reservation category: ST, SC, OBC-NCL, EWS. The OBC-NCL certificate must be a current one (2025) from the designated issuing authority.
- d) Co-curricular activities carrying weightage: NCC, NSS.
- e) Differently Abled (DA), Sports, Wards of Ex-Servicemen (WESM) certificates wherever applicable.
- f) Three numbers of passport-sized photographs.
- g) APAAR ID (candidates should ensure that there is no data mismatch between the APAAR and their other documents, like academic certificates, AADHAR/PAN Card)

Of the 17 seats allotted to the CUET, one has remained vacant and the same will be added to the RGUCET seats as per the RGU Notification cited below. If any candidate fails to pay the Admission Fee, their seat will also be transferred to the RGUCET quota as per the RGU Notification No. AC-56/RGUCET/2022 (Vol. IV) dated 28 July 2025.
