

Rikam, Registrar while extending warm welcome to all the members informed that the 63rd Meeting of the Executive Council has a total of 18 (eighteen) agenda items for consideration and approval thereof. No comments have been received so far. A copy of the minutes of the 62nd meeting of the Executive Council was placed at Annexure-1.</p> <p>Decision: The Executive Council perused and confirmed the minutes.</p>

EC:63.03	<p>To confirm and approve the Minutes of the 30th meeting of the Finance Committee held on 26.08.2025.</p> <p>The minutes of the 30th meeting of the Finance Committee of Rajiv Gandhi University was held on 26.08.2025 to discuss various issues. A copy of the minutes of the 30th meeting of the Finance Committee was placed at Annexure-3.</p> <p>Decision: The Executive Council perused and confirmed/approved the Minutes of the 30th Meeting of the Finance Committee.</p>
EC:63.04	<p>Promotion of Chief Medical Officer (Non Functional Selection Grade) under Dynamic Assured Career Progression (DACP) Scheme.</p> <p>The Executive Council noted that Dr. Akin Tana Tara and Dr. C.D. Kim applied for promotion to the post Chief Medical Officer (CMO) (Non Functional Selection Grade) under Dynamic Assured Career Progression (DACP) Scheme. Both were accorded with re-designation as CMO w.e.f. 27-03-2021 under Dynamic Assured Career Progression Scheme. They have completed 04 (Four) years of service as CMO on 26-03-2025 at Pay Level-12. As per Office Memorandum of Ministry of Health & Family Welfare, CHS Division vide No.A.45012/2/2008-CHS.V dtd.29-10-2008 and UGC's Letter No.F.4-4/2009(JCRC) dtd.09-06-2011 the GDMO Sub-Cadre are eligible to be promoted and re-designated as CMO (Non Functional Selection Grade) at Pay Level-13 (Annexure-04).</p> <p>Decision: The Executive Council perused and decided that the matter should be routed through the Departmental Promotion Committee (DPC)/Screening Committee, and the report may be placed in the next meeting of the Executive Council.</p>



<p>EC:63.05</p>	<p>To consider change of nomenclature of the Hindi Officer as Deputy Director (Official Language).</p> <p>The Executive Council noted that Mrs. Gumpi Nguso (Lombi), Hindi Officer has submitted a letter requesting for change of designation of Hindi Officer as Deputy Director (Official Language) without any financial benefit. She is already drawing the pay scale equivalent to Deputy Director (Official Language) with Rs. 83,300/- in the Pay Level-11, Cell-8. The request letter and Office Memorandum of DoPT on nomenclature and equivalent pay was placed at Annexure-05.</p> <p>Decision: The Executive Council perused the matter and resolved to constitute a committee to examine the structure of cadre in the Hindi Cell in line with DoPT and UGC norms by drawing an analogy from other Central Universities, and the report may be placed in the next meeting of the Executive Council.</p>
<p>EC:63.06</p>	<p>To consider correction of Statute 10 of Rajiv Gandhi University relating to the constitution of the Court.</p> <p>The Executive Council noted that the University was published in the Gazette of India: Extraordinary (Part III- Sec.4) dated 9th June, 2017 (copy enclosed), wherein an inadvertent mistake occurred in the printing. The heading was printed as "Draft Amendment to Statute 10 of Rajiv Gandhi University relating to the constitution of Court" instead of the correct wording "Amendment to Statute 10 of Rajiv Gandhi University relating to the constitution of Court." A corrected English version of the said amendment was enclosed herewith. The University shall approach the Controller of Publication, Department of Publication, Civil Lines, New Delhi, for publishing the corrected version in the Gazette of India.</p> <p>Decision: The Executive Council perused and approved the same. However, the amendment shall be in tabular form – 'Existing Provision' and 'Provision after proposed amendment' by omitting word 'draft' inserted inadvertently in the clause.</p>
<p>EC:63.07</p>	<p>To Consider counting of past services of Ms. Moyir Riba for promotion under CAS.</p> <p>The Executive Council noted that as per the minutes of the Committee vide notification No.ET/PF-195/MR/2022 dated 23.03.2023 under the chairmanship of Prof. R.C. Parida, the then Director , IQAC the Committee has recommended the following:</p> <p>(i) The past service of Ms. Moyir Riba with IDE shall be counted for the promotion under CAS.</p> <p>(ii) She shall also be eligible for pay protection as per rules.</p> <p>Further, as per the directives of the Competent Authority the matter was kept in abeyance due to non clearance of her probation period. Recently she has cleared her probation period on 25.05.2023 vide order No. 116/Estt/Teach-2000(Vol-VI) dated 5th May, 2025. The minutes was placed at Annexure-07.</p> <p>Decision: The Executive Council perused and approved the same as a special case keeping in view her dedicated and sincere services to the university. However, this shall not be treated as a precedent in the future.</p>

<p>EC:63.08</p>	<p>To Consider engagement of Professor of practice/Visiting Professor</p> <p>The Executive Council noted then 55th DBS Meeting Minutes, Department of History held on 6th June 2025 under its Agenda 05(I) examined the present strength of the faculty members in the dept. and the teaching load of the Dept. Given the delays in appointment and resignation of the Guest Faculty, the Board proposed that professor of practice should be engaged in the dept for the greater interest of the student and academic activity.</p> <p>In this connection, SOP pertaining to Professor of Practice/Visiting professor approved in the 47th AC held on 13th June 2024 and UGC policy Guidelines on Engagement of Professor of practice was placed at Annexure-08.</p> <p>Decision: The Executive Council perused and approved the proposal. The SoPs to be ratified and circulated widely.</p>
<p>EC:63.09</p>	<p>To consider release of periodical increment in respect of Prof. Ranjit Tamuli (retired).</p> <p>The Executive Council noted that, in accordance with the order of the Hon'ble Gauhati High Court, WP(C)52/2022 the removal of Prof. Ranjit Tamuli from the post of Vice-Chancellor at Dibrugarh University, shall have no bearing on his service benefits at Rajiv Gandhi University. Accordingly, Professor Tamuli is entitled to all pending periodic increments subject to submission of APAR for the entire period.</p> <p>Decision: The Executive Council thoroughly perused and accepted the judgment pronounced by the Hon'ble Gauhati High Court. It was resolved that Prof. Tamuli's pay shall be fixed on the basis of his Last Pay Certificate (LPC).</p>
<p>EC:63.10</p>	<p>To consider refund of Licence fees, Water Charges, Group Insurance and Personal contribution to CPF in respect of Dr. M.C Behera, (Ex-Professor, AITS).</p> <p>The Executive Council noted that, Dr. M.C Behera, Ex-Professor, AITS (who was dismissed from the service on 11.12.2023) has requested the University to refund the License fee, Water Charges, Group Insurance and personal Contribution of CPF. In this regard, the CA and Legal Advisor of RGU has recommended to place the matter before the Finance Committee (FC) and Executive Council (EC) for a decision. The FC vide Item No.FC:30:08 approved the refund of License fees, Water Charges and Group Insurance and with regards to employees' personal contribution to CPF representatives from IFD and UGC advised that the amount may be released subject to adjustment/recovery of any outstanding dues if any.</p> <p>Decision: The Executive Council perused and resolved that his all eligible dues shall be released prior to his dismissal from the services of the university i.e. 10.12.2023.</p>
<p>EC:63.11</p>	<p>To consider withdraw impugned order and restore increment of Dr. Anil Milli.</p> <p>The Executive Council noted that, in pursuant to the decision of the 59th Executive Council meeting held on 30.08.2024, the Executive Council had imposed minor penalty as per Rule 11(iv) of the CCS (CCA) rules and decided to withhold one increment in respect of Dr. Anil Milli, Associate Professor, Dept. of Physical Education. Dr. Anil Milli vide his representation dated 29.08.2025 requested to withdraw the impugned order No. ET/PF-427/AM/2023 dated 05.09.2024 and restore his increment.</p>

Decision: The Executive Council perused the matter and resolved to keep it in abeyance.

In exercise of the provisions of the Rajiv Gandhi University Act, 2006 (No.8 of 2007) under Statutes (Section 30), Clause7(3), Prof. Otem Padung, Finance Officer has been granted extension vide Notification No.PF-576/2020/OP dt.12-08-2025 for a period of one year w.e.f. 01-09-2025 (F.N.) or until his successor is appointed and enters upon his service whichever is earlier.</p>												

2. Administrative approval was accorded to set up Internal Academic Audit (IAA) which shall be temporarily attached with office of the Internal Quality Assurance Cell (IQAC), subject of ratification of Executive Council meeting.
3. Pursuant to the decision taken in the 51st meeting of the Academic Council held on 11.04.2025, under item No. AC;51:27, administrative approval was accorded to shift the Department of Food Technology from Faculty of Agricultural Sciences to Faculty of Engineering and technology, subject to approval in next meeting of the Executive Council.
4. As approved by the 60th Executive council held on 30.09.2024 vide item No. EC:60: 11 , an amount of Rs. 1,000/- was additionally enhanced to all the Contingency employees. Subsequently, University in conformity with govt. of Arunachal Pradesh notification No.Est-II-20015/211/2023-Estt-II-FPID/268 dated 19.03.2025 and in pursuant of 62nd Executive council vide item No.EC:62. (4) has revised the remuneration in respect of contingency employees as per the slab provided.

However, in pursuant to the approval of the competent authority, the enhanced amount of Rs.1,000/- is subsumed in the order No. Estt-578/Contg/2020 dated 18.08.2025.
5. Dr. Shashank Yadav, Ex-Assistant Professor, Dept. of Sociology, has submitted his technical resignation and is accepted by the Competent Authority and therefore he is relinquished from the services of Rajiv Gandhi University on 15.09.2023 for enabling him to join the post of Assistant professor in Indira Gandhi Open University, New Delhi.
6. Dr. Vivek Kumar Singh, Assistant Professor, Dept. of Physical Education of this University was granted another period of one (01) year Lien w.e.f 14.06.2025 to 13.06.2026 to enable him to continue as Associate Professor (Deputation) at Sport University of Haryana, Rai Sonipat.
7. Dr. Anamika Yadav, Ex-Assistant Professor, Dept. of Education, has submitted her technical resignation and accepted by the Competent Authority and therefore she was relinquished from the services of Rajiv Gandhi University on 14.11.2023 for enabling her to join the post of Assistant professor in University of Allahabad, Prayagraj, Uttar Pradesh.
8. Dr. Vivek Singh, Ex-Assistant Professor, Dept. of Education, has submitted his technical resignation and accepted by the Competent Authority and therefore he was relinquished from the services of Rajiv Gandhi University on 14.11.2022 for enabling him to join the post of Assistant professor in University of Allahabad, Prayagraj, Uttar Pradesh.
9. Mr. Moji Riba was granted 735 days Extra Ordinary Leave w.e.f 27.09.2021 to 02.10.2023 on medical grounds without pay, allowances and Increment.
10. The tenure of Prof. Rabi Narayan Mishra as Visiting Professor in the Dept. of Library and Information Sciences has been extended for the next semester.



<p>EC:63.17</p>	<p>Reporting Item:</p> <p>Report on development activities initiated by the University at the Extension Centre at Kamki, under Kamba Circle, Aalo, West Siang District, Arunachal Pradesh.</p> <p>The Executive Council noted that the matter was deliberated at length in the 52nd Academic Council meeting held on 25.07.2025 under AOB (9) and wherein a decision was taken. The University vide letter No. RGU/EO-42/202/Vol-I dated 13.08.2025, requested the Ministry of Education, Govt. of India, New Delhi, to grant permission for establishing the Extension Centre at Kamki, under Kamba Circle, with an financial assistance of Rs. 14,16,57,487.00 as a one-time special grants. In the meantime, a University Team headed by the Vice-Chancellor (Acting), visited the proposed site of the Extension Centre/Campus of Rajiv Gandhi University at Kamki, under Kamba Circle, Aalo, West Siang District, Arunachal Pradesh w.e.f. 30th to 31st August, 2025. The visit report, along with a few observations, has been submitted for consideration.
