**CIRCULAR**

It has been observed that the Office of the Registrar has been receiving letters from the Heads and Directors of various Departments/Institutes requesting the issuance of official letters to different check gates (Gumto, Railway Stations, Banderdewa, Hollongi, etc.) for allowing a large number of participants/delegates to attend or deliver addresses/lectures during seminars, workshops, and similar events organized by them.

It has also been noticed that, on several occasions, individual employees as well as Heads/Directors have been approaching this office with requests to allow resource persons, visiting faculty members, and their relatives to enter the University Campus.

In this connection, a letter has been received from the Officer-in-Charge, Police Station, Doimukh, vide Letter No. DMK/PS-49/2023-25 dated 10th November 2025, advising that all such visitors should obtain a valid Inner Line Permit (ILP) from the competent issuing authority. This measure is necessary to prevent potential law and order issues that may arise if individuals are allowed entry without an ILP.

Therefore, all concerned are hereby requested not to approach the Office of the Registrar for issuing request letters to different check gates in Arunachal Pradesh for allowing visitors to enter the Rajiv Gandhi University Campus for any reason.

This directive is issued in the best interest of the University community.
